2.Price of Attendance

If you choose any of the two eligible programs for Federal Student Aid (Dentistry-Dual Degree Program and CIRO/International Dental Program), you will find the cost of attendance (COA), which includes tuition and fees, books and supplies, room and board, as well as, transportation cost. Occasionally, there may be additional costs for your course, if so; your school will let you know in advance.

Please be aware that Foreign Educational Institutions are not required, as a matter of, Title IV eligibility to obtain an EIN and complete Form 1098-T for U.S. students enrolled. Therefore, the Universidad De La Salle Bajío, A.C. does not have an EIN, consequently, does not provide the Form 1098-T to students.

Important Disclosure:

The Dental Board of California, has announced important changes on the Board's Approval of Foreign Dental Schools, as of January 1, 2024, in order to remain an approved foreign dental school in California, all schools previously approved by the Board must complete the international consultative and accreditation process with the Commission on Dental Accreditation of the American Dental Association or a comparable accrediting body approved by the Board.

Although the current accreditation of the Universidad De la Salle's Faculty of Dentistry was approved by the Dental Board of California in 2019 for seven more years, until May 2026, the new announced bill, affects prospective and currently enrolled students.

Therefore, it is very important that students currently enrolled in the Dentistry –Dual Degree Program, as well as, in the CIRO-IDP are aware and understand that they must complete their study program including the required exams, by December 31, 2023, in order for their degree to be valid in the state of California.

Consequently, as of January 2021 the Universidad De la Salle Bajío, A.C., will no longer enroll new students in the Dentistry –Dual Degree Program, and will stop enrolling new students in the CIRO-International Dental Program, as of January 2022. These precautionary measures will take effect immediately until further notice.

Additionally, it is informed that the University is taking the necessary actions to complete the international consultative and accreditation process with the Commission on Dental Accreditation of the American Dental Association, as soon as possible, to continue being an approved foreign dental school.

3. Refund, Withdrawal, and Return of Title IV Financial Aid

Institutional Policy

In order to pursue an academic program at the Universidad De La Salle Bajío, A.C. the accepted applicants are required to make full payment of the mandatory fees for registration, medical exam and student accident insurance by the indicated dates. The dates are established in the program's Academic Calendar. Students can view the programs calendar through the University's site for students or you can pick-up a calendar at the Department of Student Services.

Once the above mentioned fees have been paid, and you find it necessary to cancel your registration and withdraw from any academic term, no matter the cause, the University's criteria to refund the mandatory fees is as follows:

1. If you withdraw any date prior to 30 calendar days before the first day of classes for the term, your refund will be:

Registration fee 50% Medical Exam Fee 50% Student Accident Insurance Fee 50%

Once initiated the semester a refund is no longer available.

Requirements to Receive a Refund

It is the student's responsibility to request and complete the Institutional Withdrawal Form. If student does not complete the withdrawal process, an accumulation of absences to classes may result in a failing grade; grades remain in the student's permanent record.

In case you have a debt, refunds will first be applied to any outstanding balance, and whatever amount of money is left, will be refunded according to the criteria described above.

When the University Cancels a Program or Course

In the event the Universidad De La Salle Bajío cancels a Course or Academic Program, students will automatically be refunded 100% of fees paid, no request form is needed. Be aware, that students must have the original paid receipts in order to process the refund.

For International Students Registered In the International Dental Programs without Financial Aid

In the event you find it necessary to withdraw during the course of the term, your tuition fee refund will be prorated according to the following calculation:

- Total amount of tuition paid for the term **divided** by 16; the result equals the cost of tuition per week.
- The cost of tuition per week will then be **multiplied** by the number of study weeks still left in the term. The result of the multiplication will be the amount of refund due to student.

For the purpose of refund calculation, the last week you attend school, will be the week you begin the withdrawal process, no matter the day of the week you obtain the official Withdrawal Form. The number of study weeks still left in the term will be determined based on the School Calendar published by the University.

For International Students Who Have Received Funding Through Title IV of the United States Federal Government

If you have received funding through the Federal Student Aid Title IV Program, you must see the Financial Aid Office representative to discuss your eligibility, rights, and responsibilities. If you received financial assistance and do not officially withdraw, you can be subject to full aid cancellation.

In addition, financial aid monies allocated to you may need to be refunded to Title IV programs, or you may need to repay a portion of the funds received if you withdraw, drop out, are expelled, or otherwise become ineligible during the payment period. A copy of this policy is available at the Financial Aid Office.

The Return of Title IV Financial Aid Funds Policy

NOTE: This policy applies only to eligible US and eligible non-US citizens receiving Title IV funds.

The Financial Aid Office is required by Federal Regulations to calculate a Refund of Fees and a Return of Title IV funds for all students who are dismissed, withdraw, or take a leave of absence during a semester.

The Return of Title IV Funds is the amount of unearned aid you received at the beginning of the term that must be returned to the assigned federal aid programs. Any aid received in excess of the earned amount is considered unearned.

If you receive financial aid and then withdraw from your course or drop below the half-time enrolment requirement, the Financial Aid office will determine whether any of the money must be returned to the U.S. Federal Aid Program. These funds must be returned in the following order:

- 1. Federal Stafford Student Loan Unsubsidized Loan
- 2. Federal Stafford Student Loan Subsidized Loan
- 3. Federal PLUS Loan

Calculation

Regulations require the Universidad De La Salle Bajío to perform calculations within 30 days from the date the official withdrawal or dismissal is determined. The University must return any unearned funds to the lender within 45 days of the calculation.

The Universidad De La Salle Bajío is required to return any unearned amounts of Federal Title IV funds to the appropriate Federal program(s) if the student stops attending before 60% of the term is completed, as measured in days. Students who remain enrolled through more than 60% of the payment period (semester) are considered to have earned 100% of the aid received and will not owe a repayment of Federal Title IV funds.

Unearned Title IV funds must be returned to the appropriate program(s) in order to maintain aid eligibility for future enrollment periods. Any earned loan funds borrowed must be repaid according to the terms of the loan. Title IV aid is earned in a prorated manner on a per diem basis up to and including the 60% point in the semester. Title IV aid earned is calculated as follows:

of days completed by student = % of semester completed

Total # of days in semester

Note: Calculation does not include scheduled breaks of at least five consecutive days

If the Universidad De La Salle Bajío is required to pay money on your behalf to the U.S. Department of Education as a result of your early withdrawal, you will be required to repay that money to the Universidad De La Salle Bajío.

Only after these calculations and payments are made, will any remaining funds be returned to you or your parents (Parent PLUS only).

Consequences of Outstanding Repayment Obligation

The Universidad De La Salle Bajío does not have the authority to waive or write off the repayment requirement regardless of the reason for the withdrawal, including extenuating circumstances such as illness, accident, or grievous personal loss.

A student who fails to return the unearned Federal Financial Aid funds will be referred to the U.S. Department of Education for collection and the University may withhold permission to register, use facilities, or render services. Until the repayment issue is resolved; the student's record will be "flagged" every time the student files a Free Application for Federal Student Aid (FAFSA).

Process

Students who find it necessary to withdraw from the Universidad De La Salle Bajío after enrolling for any academic term are required to follow the official withdrawal procedures. Failure to follow formal withdrawal procedures may result in the assignment of failing grades in all courses and the need to apply for readmission before being permitted to enroll in another academic term.

Students needing to withdraw, begin the process by filling out the University's Withdrawal form, available at the Dental's School office.

The personal privacy and data protection regulations of the UDLSB are derived from and adhere to the Mexico federal policies in the Federal Law on Protection of Personal Data Held by Private Parties in Mexico adopted in 2010. Accordingly, the Ministry of Education in Mexico and the University both implement policies to ensure that privacy is maintained for students' personal, financial, health and educational information. 8. National Student Loan Data System

Data on federal student loans are reported to credit reporting agencies; therefore, maintaining a good repayment history is integral to protecting your credit worthiness. You can access complete data on your federal student loan history from the National Student Loan Data System website https://nsldsfap.ed.gov/nslds_SA/.

Maintaining a good credit history on education loans is important since it may affect your ability to buy things like a home, a car, or a credit card. Whenever you apply for a loan, your credit report will most likely be reviewed. In reviewing your credit report, the lender is trying to determine your ability to repay.

9. Entrance Counseling for Student Loan Borrowers

If you are a Federal Direct Loan first-time borrower, you must complete the Entrance Counseling, prior to disbursement. If you have completed entrance counseling in a previous year of study for a specific loan type at any institution, you do not need to complete this step. However, the University recommends you take the Financial Awareness Counseling as a refresh.

10. Exit Counseling for Student Loan borrowers

Federal regulations indicate that any student who has received a federal loan while in attendance at the Universidad De La Salle Bajío, A.C. must complete an Exit Counseling.

The Exit Counseling explains the rights and responsibilities of federal loan borrowers, and it is required when a student:

- Graduates,
- Drops below part-time status
- Takes a leave of absence, or
- Withdraws from the University

Any student who fails to complete the online exit counseling, will be emailed a copy of the exit counseling guide, produced by the US Department of Education.

Please note: Students who do not complete an exit interview may have their diploma and transcripts placed on hold.
